For **households not eligible** for
child allowances due to **income limits**
Up to 60,000 yen will be provided!

December 15, 2023 (Friday)

Applications will still be accepted after December 16, but payments will be made separately.



In June 2023, the government announced its “Strategic Policy for the Future of Children,” which included a policy to abolish the income limit for child allowances. In response, **until the government implements the policy**, we will support the growth of the children who will lead the next generation by providing the **city’s unique** benefits to **households that do not receive child allowances due to the income limit.**

We hope that you will understand and support the purpose of this program and use the benefits **to help your child grow.**

Eligible Persons

- Children up to the first March 31 following their 15th birthday *See table below for details.

Eligibility Period	June 2023 - March 2024	April 2024 - May 2024
Date of Birth	April 2, 2008 - March 1, 2024	April 2, 2009 - May 1, 2024

Applicants

- **Those who meet all of the following requirements**

- (1) A parent or guardian (**parent or other person with high income**) caring for an eligible child
- (2) Reside in the city
- (3) Not receive the child allowance for FY2023 (from June 2023 to May 2024) due to the income limit

*Before applying, please check who has the highest income.

Eligibility Period and Payment Amount

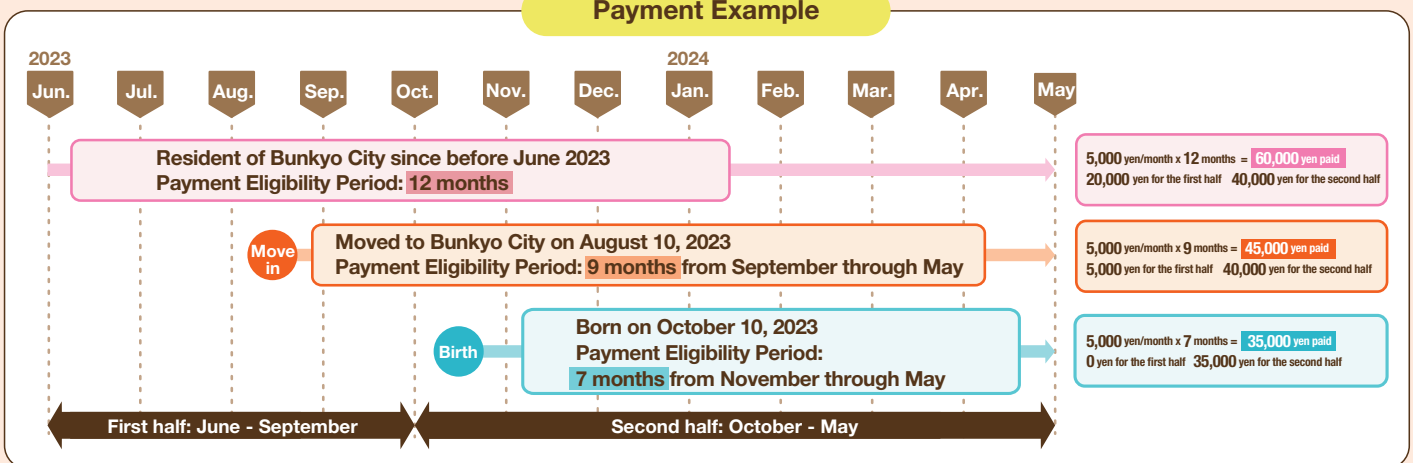
- **Eligibility period** Twelve months from June 2023 through May 2024 (planned)
- **Payment amount** 5,000 yen per month
Up to 60,000 yen per year
- **How to determine the payment amount**
5,000 yen/month x number of eligible months = payment amount

Please see the “Eligible Persons” and “Applicants” sections above for details on the requirements.

*Eligibility is determined based on the situation **as of the first day of each month**.

*Those who moved to the city or were born during the period are also eligible.

Payment Example



Payment Period

- **Divided into two payments, one for the first half and one for the second half.**

Only one application is okay

- **Lump-sum payment for the first half (up to 20,000 yen) in February 2024 (for applications received by December 15, 2023)**

*Applications will continue to be accepted after December 16, but payments will be made separately.

- **A lump-sum payment for the second half (up to 40,000 yen) in July 2024**

*The payment amount for the second half is a planned amount. It will be announced separately on our website once the budget for FY 2024 is finalized.

How to apply

- **Applications can be submitted using LINE (*) or by mail.**

(*)Registration of a LINE account is required.

*Application forms will not be accepted at the counter. Please send by mail.

*If you are unable to mail your application by the deadline, please drop it off at the “Nighttime Mailbox” at the back of the first floor of the Bunkyo City Office.
